**INTERDISCIPLINARY LEARNING AND INTERLINK WORKSHOP SERIES:  
APPLICATIONS TO SHIP MANAGEMENT AND BELT AND ROAD INITIATIVE  
FIRST SESSION, TUESDAY 28<sup>TH</sup> OCTOBER 2025**

This is the first in a series of workshops on “Inter-disciplinary Learning and Interlink” (ILI), jointly organized by the Hong Kong Logistics Management Staff Association (HKLMSA), the University of Wollongong College Hong Kong (UOWCHK). **What is Inter-disciplinary Learning and Interlink (ILI)?**

ILI is a learning and problem-solving methodology, inspired by the Renaissance polymath ideal of being “learned in the Arts, Letters and Sciences”. We apply the approach of integrating basic concepts from a range of disciplines, to resolve management-level problems, demonstrated in our workshops by case studies on Ship Management and the Belt and Road Initiative (BRI). The ILI methodology is designed to be understood by students and practitioners of all disciplines and levels of experience, with the aim to develop critical reasoning and integration of knowledge in the vast seas of information available today.

**What content will the workshops cover?**

The ILI workshop series builds on the contributions of presenters in over 40 workshops conducted in the past decade, including the three Inter-disciplinary Maritime Practice (IMP) series and the Belt and Road Initiative Forum (BRIF). The Ship Management sections will cover the entire lifespan of a ship, from the decision to purchase, to the course of trading, to its final loss or being sent for scrap. The BRI sections will cover Hong Kong’s role in promoting the BRI as part of the Greater Bay Area, and explore BRI cases at a macro and micro level. The aim is to illuminate transferable concepts and insights that apply to problem-solving across disciplines.

**How will the workshops be conducted?**

Each workshop will be conducted in an open forum case study question and answer (Q&A) format, where the participants interact with the presenters or moderators who

share their academic and practical insights. There will be an intermission for refreshments, networking and individual discussion.

The ILI Series will begin with six monthly workshops as follows:

1. Interdisciplinary Learning and Interlink (ILI) – Introduction and Applications to Ship Management and Belt and Road Initiative.
2. Ship Acquisition and Finance
3. Shipbuilding, Machinery & Equipment
4. Ship Chartering & Operations
5. Marine Insurance (Hull & Machinery, Protection & Indemnity) and Claims
6. Ship Technical Management, Repair & Maintenance

**What is the first session about?**

The first session, to be held on 28 Oct 2025, will introduce the ILI methodology, and explore examples of how ILI is applied to cases in Ship Management and the BRI.

Fully qualified in 1980 by stringent examination, becoming the first Asian Fellow of the British Association of Average Adjusters (better-known as AAA). He has been sitting on the Advisory & Dispute Resolution Panel of the AAA.
